What truly makes JCT unique, however, is that JCT integrates advanced studies in Torah with technical studies. JCT graduates through its men's institute, Machon Lev, engineers, managers and industrial leaders who are committed to Israel's future as both a Jewish state and a world technological leader. JCT is inclusive. To accommodate women who wish to study engineering while maintaining their role within the Jewish family, JCT established Machon Tal, the Women's School of Engineering in 1999. JCT actively reaches out to young people from Israel's Ethiopian community through our "Ethiopians for Engineers" program and to the Haredi community by establishing special academic programs to enable them to enter Israel's technological workforce.

We hope this pamphlet will enhance the upcoming holidays by providing insight into Judaism's approach to contemporary ethical dilemmas. JCT is privileged to promote the study of Jewish ethical values as well as its technological expertise.
